## SIGN ADVERTISING CONTRACT

THIS AGREEMENT, dated this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, is BETWEEN the DUNMORE EQUESTRIAN SOCIETY (“DES”), in the Province of Alberta and \_\_\_\_\_ known as the (“CONTRIBUTOR”) IN CONSIDERATION of a monetary payment in the amount of \$ \_\_\_\_\_.

Term of Contract (one or three year) \_\_\_\_\_ FOR sign option (2x7’ or 3x8’) \_\_\_\_\_.

**SIGN OPTIONS AND PAYMENT TERMS:**

- **2x7’ METAL SIGN** to be placed in the **BUCKING CHUTE** (DES will confirm availability)
- **3x8’ METAL SIGN** to be placed in the **OUTDOOR ARENA** area
- **\$1,500.00** plus \$75.00 GST for a **ONE** year contract
- **\$3,500.00** plus \$175.00 GST for a **THREE** year contract (\$1,250.00 payable the first year with \$875 payable at the beginning of each subsequent contract date)
- DES will pay 100% of the sign cost
- Make cheques out to the Dunmore Equestrian Society or e-transfer admin@dunmoreequestrian.com
- Signs can be purchased by the Advertising Donator at the end of their contract for 50% of the sign purchase price.

“DES” and the “CONTRIBUTOR” hereto covenant and agreed together as follows:

1. DES shall provide a professionally designed Ad Board with content and appearance to the satisfaction of DES and the Contributor.
2. DES shall permit the Ad Board to remain at the Dunmore Equestrian Centre for the said period, during which time DES shall maintain the Ad Board in a reasonable condition and shall refurbish the sign as they see fit, during this period.
3. DES is not responsible for any upgrading of the Ad Board by the Contributor (ie: change of colours, slogans, etc.) for the duration of the contract.
4. DES reserves the right to temporarily remove or cover the Ad Board should a regional, zone, provincial, national or international event or activity take place in the facility at which a specific sponsor(s) must be solely advertised for the purpose of the event or activity. Signs may also be covered because of the nature of the event.
5. The CONTRIBUTOR relinquishes all rights to either full or partial refund once this agreement between DES and the CONTRIBUTOR has been signed.
6. Monetary payments are due and payable on date of signing the contract. The year will commence upon placement of the Ad Board. Renewal shall be made one month prior to expiration date of previous contract. DES, in its’ sole discretion may remove any Ad Boards for which payments are not kept current.
