Please respect the follow guidelines:

By signing the riding pass membership form Applicants agree to hold the Dunmore Equestrian Society harmless of any claim resulting from damage or injury caused by the horse(s), riding pass member(s) or their guests and invites, to anyone, including, but not limited to, legal fees and/or expenses incurred by the Dunmore Equestrian Society in defense of such a claim.

- Horses are not permitted loose in the arena if there are other riders using the arena
- Horses are not permitted to be tied inside the arena if there are other riders using the arena
- Horses are not permitted on south (announcers' booth) and west (bleachers) sides of the arena
- If your horse needs lunging please use the round pen if there are other riders in the arena
- Use of equipment in the arena is allowed under the following circumstances:
  - a. All riders must agree to any equipment being used in the arena
  - b. If you put out any equipment (i.e. Barrels) you must put it away and close all gates when you finish your ride
- Keep your eyes up and ride defensively and conduct yourself in a safe and reasonable manner
- Carry appropriate insurance for yourself and your horse (i.e. AEF [www.albertaequestrian.com](http://www.albertaequestrian.com) )
- All horses must be controllable and controlled while on the DES property

### RIDING PASS MEMBER RESPONSIBILITIES

1. Abide by all posted DES rules and policies
2. Riding Pass Members are responsible to help keep the facility clean...please do not litter
3. All Dogs must be on a lease and under control at all times
4. Youth under 16 need to be supervised at all times
5. Privileges may be revoked for any breach of DES rules and policies
